Standards audited

• The organisation operates as both a registered training organisation providing accredited and non-accredited training along with providing consultancy services to key clients in the competitive manufacturing sector. Its focus is on providing a business solution to its clients rather than a qualification. In so doing the solution may lead to staff participating in a qualification.

Essential Standards for Continuing Registration 15, 16, 17, 18, 20, 22, 23

- A key driver of the operations of the organisation is utilising the Malcolm Baldrige Excellence award as an annual benchmark commencing in November each year. This involves conducting an internal survey of key points – the resultant gap analysis provides a focus of operations for the following year. Furthermore the organisation conducts quarterly reviews, monthly management meetings and weekly coordinator meetings and daily team planning sessions.
- The services are supported by a managing director, a customer service manager, training and sales administrators and assistants and trainers/consultants.
- The organisation has identified future areas of growth for the RTO revolved around the glass industry.
- Clients are generally from industry.
- Training occurs at the RTO's premises or at the client's site.
- A partnership arrangement is in place with Leading Performance Consulting Pty Ltd.

Audit Findings

The organisation was found compliant with the **Standards for NVR Registered Training Organisations 2011 (SNR)** - **Essential Standards for Continuing Registration 16 and 20.**

The organisation was found not compliant with **SNR 15, 17, 18 and 23**. The level of non-compliance was considered to be significant largely due to deficiencies identified in assessment materials addressing training package requirements.

Assessment tools examined for the above units do not fully address the requirements of the MSA07 Manufacturing Training Package. While some of the knowledge requirements had been addressed, there was insufficient evidence assessment tools sufficiently address required knowledge, skills and critical aspects of evidence. Furthermore, there was no guidance for assessors that ensures performance standards are consistent with the requirements of the training package and that assessment is conducted consistently across a range of assessors and learners.

In addition for unit of competency *MSACMT421A* as one of the assessment tools was a group project, no evidence was provided to demonstrate how the assessor had determined each learner's contribution to the assessment and ensured that only learners who hold the requisite skills and knowledge were certified as competent.

Assessment records examined demonstrated that students have been determined to be competent without appropriate evidence having been gathered or retained.

TAE40110 Certificate IV in Training and Assessment

TAEASS402B Assess competence

No assessment tools were provided at audit for the above unit of competency. Consequently the organisation did not demonstrate it has assessment tools that meet the requirements of the TAE10 Training Package and that the assessment of the above unit will be conducted in accordance with the principles of assessment and rules of evidence.

Assessment records examined demonstrated that students have been determined to be competent yet no evidence was available to support the determination of competence.

No evidence was provided that assessment has been systematically validated.

Furthermore, insufficient evidence was provided to demonstrate how the assessment judgement confirmed the competence of Philip Preston for the award TAE40110 Certificate IV in Training and assessment – issued by the RTO on 6/05/11.

BSB51107 Diploma of management

BSBWOR501B Manage personal work priorities and professional development

Assessment tools examined for the above unit does not fully address the requirements of the BSB07 Business Services Training Package. While some of the knowledge requirements had been addressed, there was insufficient evidence assessment tools sufficiently address required knowledge, skills and critical aspects of evidence. Furthermore, there was no guidance for assessors that ensures performance standards are consistent with the requirements of the training package and that assessment is conducted consistently across a range of assessors and learners.

Assessment records examined demonstrated that students have been determined to be competent without appropriate

evidence having been gathered or retained.

TLI40107 Certificate IV in Transport and Logistics (Warehousing and Storage)

This program has only previously been delivered under a partnering arrangement with Vative Pty Ltd. The partnering agreement was cancelled on the 4 August 2011. No assessment tools were provided at audit for the above units of competency. Consequently the organisation did not demonstrate it has assessment tools that meet the requirements of the TLIO7 Training Package and that the assessment of the above units will be conducted in accordance with the principles of assessment and rules of evidence.

Assessment records examined demonstrated that students have been determined to be competent yet no evidence was available to support the determination of competence.

No evidence was provided that assessment has been systematically validated.

SNR17

Insufficient evidence was provided to demonstrate the partnership agreement with Vative Pty Ltd for the delivery of TLI40107 Certificate IV in Transport and Logistics (Warehousing and Storage) was monitored as required. As training and assessment materials and student records for TLI40107 Certificate IV in Transport and Logistics (Warehousing and Storage) delivered in partnership with Vative Pty Ltd, have not been provided to Improvement Tools (QLD) Pty Ltd as required.

SNR 18

The non-compliances identified at audit demonstrate the organisation's chief executive has not ensured the NVR registered training organisation has complied with the VET Quality Framework across its operations and entire scope of registration.

SNR 23

The statement of results for qualification testamurs is titled "Statement of Attainment of Results"; and displays the NRT logo this has the potential to be incorrectly identified as a statement of attainment.

Following the analysis of the assessment tools provided as evidence, it has been identified they do not fully address all the requirements of the MSA07 Training Package. The organisation provided evidence of amended assessment tools which now include direction for the assessment of group activities; however, insufficient evidence was provided to demonstrate how the practical assessment tasks sufficiently address the unit's required skills due to the assessment tasks not being supported by guidance to assessors of the performance levels required or ensure sufficiency and consistency of assessment judgement across a range of assessors and learners.

Following the analysis of the rectification evidence provided, it was identified the assessment tools do not fully address
the requirements of the MSA07 Training Package, in particular, the practical assessment tasks do not sufficiently address

evidence was provided to demonstrate how the practical assessment tasks sufficiently address required skills; as these
